**LIQUOR BY THE DRINK - FULL LIQUOR LICENSE (Monday through Sunday)**

Sale of intoxicating liquor of all kinds at retail, by the drink and for consumption on the premises where sold, and the sale of intoxicating liquors in the original package.

**LIQUOR BY THE DRINK – RESTAURANT/BAR (Monday through Sunday)**

Sale of liquor of all kinds by the drink at retail for consumption on the premises of any restaurant/bar with at least 50% income from food sales.

\$300.00 per year

**PACKAGE LIQUOR LICENSE - ALL KINDS (Monday through Sunday)**

Sale of intoxicating liquor, malt liquor, and or non-intoxicating beer in the original package not to be consumed on the premises where sold.

**LIQUOR BY THE DRINK – 5% BEER & WINE (Monday through Sunday)**

Sale of 5% beer and wine by the drink at retail for consumption on the premises.

**PACKAGE LIQUOR – 5% BEER (Monday through Sunday)**

Sale of 5% Beer at retail in the original package not for consumption on the premises where sold.

**LIQUOR BY THE DRINK – 3.2% BEER (Monday through Sunday)**

Sale of 3.2% by the drink at retail for consumption on the premises.

**PACKAGE LIQUOR – 3.2% BEER (Monday through Sunday)**

Sale of 3.2% Beer at retail in the original package not for consumption on the premises where sold.

**TEMPORARY PERMITS – BY THE DRINK FOR CERTAIN ORGANIZATIONS  
(7DAYS MAX)**

Any person, who possesses the qualifications, meets the requirements and complies with the provisions of Section 600.030 (c) may apply for a special permit to sell intoxicating liquor for consumption on premises where sold.

**TASTING PERMIT**

Any person, who is licensed to sell intoxicating liquor in the original package at retail, may apply for a special permit to conduct wine, malt beverage and distilled spirit tastings on their licensed premises.
